The Mayor and City Council of Lyndon encourage and welcome comments from the public at City meetings. Regular City meetings are held at 6:00 p.m. the third and fourth Monday of each month at City Hall, 515 Wood Road. Anyone wishing to address the Council concerning items of interest may do so for up to six minutes. The person addressing the Council shall, when recognized, state their name and address for the record, including if they are a resident of the City. A minimum of 9 copies should be provided if you are submitting handouts to each Council member. The Council reserves the right to delay any action, if required, until such time when they are fully informed on the matter. After Council approval, written minutes, not verbatim transcripts, are available on our website.

Debris and Bulk Waste Reminder

With the recent storms that brought down many trees and limbs in our area. We would like to remind our residents of the policies and procedures for collection of yard waste:

- Yard waste includes the following: grass clippings, leaves, flowers, vegetable plants, brush, tree limbs, and shrubbery trimmings.
- Yard waste can be placed in a reusable container or paper yard waste bags. The reusable container should be labeled "Yard Waste". Stickers are available for labeling your Yard Waste can at Lyndon City Hall.
- Tree limbs must be cut and tied in no longer than 4' lengths and the bundle no larger than 3' in diameter. No tree limbs over 3" in diameter will be accepted.
- Bundles of tree limbs cannot weigh over 50 pounds.

Yard waste is collected weekly

Also, Rumpke collects one large/bulk household item per week, provided you call Customer Service 48 hours in advance at **(502) 568-3800.** Mattresses and upholstered items must be wrapped in disposable plastic prior to collection.


