The City of Lyndon response rate is currently at 70% and ranked 123 out of 415 Kentucky cities. WE CAN DO BETTER! The splash pad will remain closed for this season. It is simply not possible to enforce social distancing measures due to the size of the facility.



CARES GRANT PROGRAM

In response to Governor Andy Beshear's public Health Disaster Emergency Declaration on March 6th, 2020, the City of Lyndon is providing relief to small businesses impacted by the COVID-19 pandemic. Non-profit organizations which provide food, supplies and relief to impacted individuals are also eligible. The funding is provided through the federal CARES Act, a portion of which has been allocated to Kentucky cities by the State of Kentucky.

To expedite the application process, small businesses and non-profits should visit **www.cityoflyndon.org** and review the checklist carefully, as it lists what is needed for a successful application submission. Applications can be submitted via email to citylyn@cityoflyndon.org or through the postal service at City Hall's address. Please visit our website to determine if your business is eligible and for more information. Further detail on allowable expenditures is available through program details available on Kentucky Department for Local Government website entitled Coronavirus Relief Fund, Guidance for State, Territorial, Local and Tribal Governments, April 22nd, 2020.

The CARES Grant program will be operated on an equal access/non-preferential (i.e. first-come first-serve basis). Once the funds allocated by the City of Lyndon for this grant program are awarded, no additional applications will be considered. The only expenditures which can be considered are Covid-19 related expenditures which occurred between March 1, 2020 and December 30, 2020.

We will be accepting applications from **August 1, 2020 through September 30, 2020**. After the deadline, a committee comprised of the Mayor and two appointed Council members will review and award businesses who qualify. Once the grants have been awarded, the names of businesses and the amount they were awarded will be published on our website to ensure full transparency. Monthly City Meetings 6:00 PM
