Each space is 12 x 12 and is located in a grassy area. The space is the only thing provided. Bring your own covers, tables, chairs, etc. We are unable to supply you with electricity or lighting; you must provide your own. You may begin setting up your booth at 9:00am on Friday. **ALL VEHICLES MUST BE MOVED TO THE GENERAL PARKING AREA NO LATER THAN 2:00 P.M. ALL BOOTHS MUST BE UP AND RUNNING BY 4:00 P.M. ON FRIDAY. NO LATE ARRIVALS WILL BE ALLOWED.** We will have live entertainment both nights and fireworks at dark on Saturday. Because this is a municipal park, no alcoholic beverages are allowed. A dumpster is provided for trash removal and each participant is responsible to see that their trash is placed in it. The trash receptacles placed on the grounds are for the convenience of the attendees only.

Form must be signed (including waiver) and returned with payment of \$100 by May 6th (LABA Members will be charged \$50.) If an extension is granted, all forms received after May 6th will be imposed a \$25 late fee. If you are requesting more than one space, you will be charged full price for each additional space. Fees are non-refundable. All participant activity must be conducted from their booth space. No participant is allowed to move about the grounds & conduct their activity except by written approval of the Lyndon Area Fair organizer.

2011 Lyndon Area Fair Participant Waiver Form

This is a Legal Document. Do Not Sign Unless You Fully Understand It.

Waiver Of Liability: This waiver is effective from June 9, 2011 thru June 12, 2011 (or on such other dates as may be determined in the event of a postponement of the Event) in consideration of participating in the Lyndon Area Fair held at Robsion Park, Robsion Park Drive, Louisville, Ky. 40222.

I know that participating in this event is a potentially hazardous activity. I should not enter or participate unless I am medically able. I agree to abide by any decision of an event official relative to the event. I assume all risks associated with participating in the event including, but not limited to: falls, contact with other participants, the effects of weather, including high heat and/or humidity, fireworks and their debris, and the conditions of the area. Having read this waiver and knowing these facts and in consideration of allowing me to participate in the Lyndon Area Fair (hereinafter sometimes referred to as the "Event") I intending to be legally bound do hereby for myself, my heirs, my executors and administrators agree as follows:

1. I do waive and forever release any and all rights and claims for any damages and liabilities of any kind arising out of my participation in this Event against all persons, entities, and agencies involved with conducting and promoting the Event including the City of Lyndon, the Lyndon Area Business Association, The Lyndon Fire Protection District, their agents, successors, representatives, and assigns even though that liability may arise out of negligence or carelessness on the part of persons named in the waiver.
2. Further, I assume the risk of all bodily injuries, including death, resulting therefrom, and personal injuries to me and anyone entrusted to my care, damage to and loss of our property, including loss of use thereof and any other indirect or consequential damages, resulting directly or indirectly, wholly or in part, from our participation in the Event or while traveling to or from the Event.
3. Further, I hereby agree to indemnify, defend, and hold entries specifically named in paragraph 1 above harmless from any and all claims, liabilities, losses, damages, costs, expenses (including attorney's fees), judgments, and penalties arising out of acts or omissions to act.
4. Further, in the event that the participant is under 18 years of age, the undersigned parent or legal guardian of the participant agree to indemnify, defend, and hold harmless the entities named in paragraph numbered 1 above from and against all claims, liabilities, losses, damages, costs, expenses (including attorney's fees), judgments, and penalties arising out of the participants participation in the Event.
5. Further, I understand that the City of Lyndon, the Lyndon Area Business Association, and the Lyndon Fire Protection District have the right to any photographs or images from these events for promotion and/or advertising.
6. Fair organizers reserve the right to refuse entry or close down any booth that presents unsuitable merchandise, written material or inappropriate behavior in the opinion of the Lyndon Area Fair organizer. No booth fee will be refunded in such event.
7. Motor vehicles are not allowed to drive through the park during the event.
