#### CITY OF LYNDON CAUCUS MEETING MINUTES MONDAY, MARCH 17, 2025

Mayor Brent Hagan called the Meeting to order at 6:00 p.m. Those present: Susan Barto, Jenny Benner, Becky Ricketts, Mardy Sidebottom, Vicki Stanley, Amy Stuber, Jim Yates and City Attorney, John Singler. Few guests were also present.

Mayor Hagan began with review of the Police Headquarters furniture bid comparison arranged by LMH Architecture. MBI and ID&A were the two companies who submitted bids last month. MBI came in as lowest bid with \$80,947.19 for both base bid (main floor \$41,827.20) and alternative 1 (community room in basement \$39,119.99). There was discussion regarding what was included in base bid and possibilities of later purchases for basement. Mayor confirmed funds would come out of capital projects in budget. More discussion will be held at Council Meeting.

Mayor Hagan also announced bids for Lyndon Lane Streetscape project which were due today and only one company, Hall Contracting, submitted a bid. City Attorney, John Singler, opened the bid and total was \$234,400. The Mayor read the specifications. Discussion was held and action will be on agenda for next week. Mayor will reach out to Hall and determine start date.

Mayor informed council the City of Lyndon will have it's 60<sup>th</sup> Anniversary this year as a city, incorporated in 1965. Mayor mentioned possible celebration event. Becky Ricketts suggested to commemorate anniversary with the summer festival to save on cost. Discussion was held.

Council member Vicki Stanley, updated details on Ad Hoc Committee. She stated she is waiting on one person to confirm and dates will be discussed. Mr. Singler explained there needs to be communication with office and 24 hours to post on door and on website.

Council member Jenny Benner asked for update on the state of the audit. Mayor Hagan explained he has spoken the auditor, Mr. Paulmann who has sent back corrections that were requested. Mayor spoke to Myron Fisher from Baldwin CPAs who informed him they are not interested in conducting any review while the city is still under contract with current auditor plus, if audit is similar to current one, he fears a negative impact on reviews. Other factors and timelines would not be in City's favor to explore another audit. Mayor Hagan also found it is not required for council to approve an audit, they must only review it. Mr. Singler also added he has called the DLG to advise City on next steps. Ms. Benner asked Mayor if he finds audit to be acceptable. He said with no material issues and only grammatical and organization disputes, it is comparable with past audits that were approved and will wait for advice from DLG. More discussion held. Council member, Amy Stuber, pointed out an issue with a \$1M line item discrepancy in public safety. Mayor stated that Mr. Paulmann is reviewing this inquiry. Ms. Stuber asked what will happen if DLG finds an issue and Mr. Singler stated the city will be asked to correct the matter. Ms. Stuber also mentioned in the 22-23 audit, there was a difference of \$69,000 on audit from actual financial statements. Mr. Singler requested more detail from Ms. Stuber and said he would need more time to review.

Ms. Benner proposed a budget amendment to increase professional fees in order to hire a CPA to assist with audit and budget season. Mayor said he agreed and once they get quotes and choose a CPA, the budget can be amended. Mr. Singler also commented that a CPA would be beneficial to the city in many areas. Mayor Hagan stated he will also propose a professional fee increase to hire full-time employee to handle occupational taxes and business licenses. Discussion was held.

Mr. Singler returned to Ms. Stuber on the 22-23 audit discrepancy making sure he understood what her CPA was stating. Mr. Singler explained it is common for there to be some differences from audit figures and quarterly statements because the auditor has made his adjustments. Ms. Stuber asked if the end of the year financials should match the audit. Mr. Singler informed her that normally, the auditor would suggest what needs to be corrected and that could be a requirement once audit is completed but the quarterly statements on the website is what the Treasurer submitted. It was brought up the audits have been taken off the website in the transition of the website platforms. Mayor said he will make sure those are put back on.

Council member Becky Ricketts asked for update on audio update. Mayor stated he has an appointment on Friday with another individual and should have info on Monday. There was discussion around the audio and video option. Ms. Stuber was under the impression quotes were also for video but Mayor was told by several council members they were only interested in audio. Ms. Ricketts reminded council of an email she sent of a video option if they want to review. Mr. Singler gave Douglass Hills council video as an example and asked them to look at their setup online.

Mayor Hagan opened up floor to the public. No one chose to speak on any topics.


