SNOW REMOVAL REMINDER

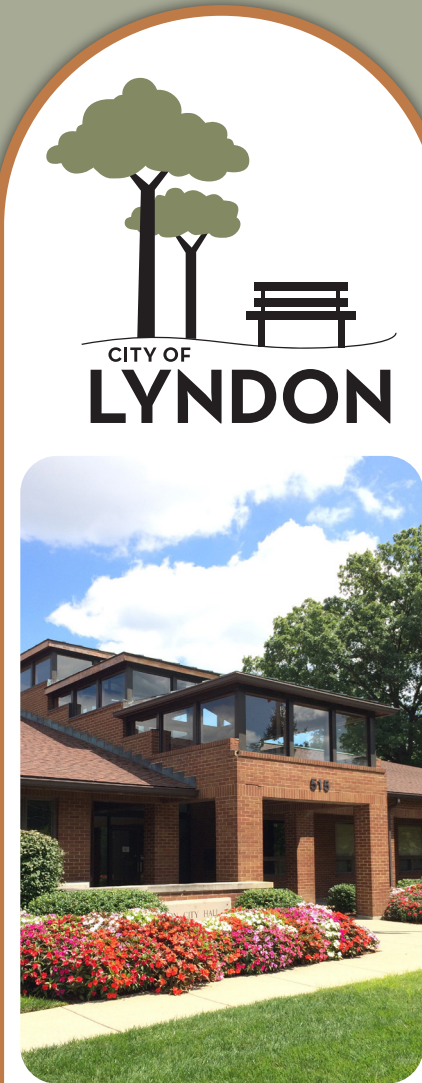
During certain snow events, the City may mobilize our contracted snow removal team. If heavy snow is forecasted, please remove all vehicles from the streets so that crews can effectively navigate our roadways and avoid any accidents. Our contract reads that a snow event that produces more than 4" would require that all Lyndon public roadways be treated. Temperature plays an important role on whether our snow team salts intersections and priority through streets. When below 20°F, the salt is not effective and spreading it would be a waste of resources. With most storms in the Ohio valley, forecasting is unpredictable. If we can be proactive, we certainly will be. All the main thoroughfares within City boundaries, i.e., Lyndon Ln, New Lagrange, LaGrange, N. Ormsby and Whipps Mill are all maintained by Louisville Metro public works. Streets within 'neighborhoods' that are considered main access points to the major roadways listed above are 'priority' and those with major slopes are also considered. Many 'no outlet' streets that are tributaries to these streets will only be treated after priority streets have been cleared and maintained depending on the severity of the snow event. As always, pay attention to warnings issued through news outlets and give yourself plenty of time to reach your destination.

Lyndon - KLC Certified City of Ethics

The City of Lyndon was recently certified as a "Certified City of Ethics." "It's an important accomplishment because our role as elected officials and employees of the city is to serve our citizens efficiently, effectively and with honesty and transparency. The Council and I felt the process and requirements to earn this certification would be a good way to vet and affirm our commitment to these important principles," said Mayor Hagan.

Residents and businesses expect efficiency, inclusiveness, and ethical leadership from local government. Certification under the Kentucky League of Cities (KLC) Certified City of Ethics Program is a way to recognize cities and city officials that have adopted principles and procedures that offer guidance on ethical issues, and a mechanism to resolve complaints at the local level. In addition, this program increases public trust and confidence in city governments and their services through the training and recognition that this program promotes.

The ordinance guides conduct of city officials and their employees in areas such as financial disclosures, conflicts of interests and outside employment. The ordinance also contains strong penalty provisions – including public reprimands, fines, and removal - for city officials and employees who violate the ordinance. To maintain the certification, the city must go through this process every four years.

KLC reviewed the code of ethics ordinance to determine if they comply with the criteria set out in KRS 65.003. The city received a plaque and is now authorized by KLC to use a "Certified City of Ethics" logo on stationery, road signs and other uses.

NORTHEAST REGIONAL LIBRARY AWARDS

In September of this year, the Northeast Regional Library was awarded the 2021 AIA Kentucky Honor Award, the highest honor for architectural design by the Kentucky chapter of the American Institute of Architects. The library was designed by JRA Architects, MSR Design and MKSK with the help from community leaders, residents and the LFPL (Louisville Free Public Library) staff.

Along with over \$120,000 books and other material, meeting rooms and learning areas, the library also features a space called the "Maker Pavilion". The LFPL described this area as "a hub for making, collaborating and Interactive learning" which includes the latest technology in printing, music, videography, and cooking. The library serves more than 170,000 people in Jefferson County.

The Northeast Regional was also awarded the LEED Gold-certification in June of 2020. LEED stands for Leadership in Energy and Environmental Design.

N. ORMSBY LANE SIDEWALK COMPLETION

District 7 Metro Councilwoman Paula McCraney recently pledged \$60,000 to complete the sidewalk on the north section of Ormsby Ln., which currently ends at Partridge Walk Ln. from Westport Rd. Lyndon had already committed \$60,000 in past budgets anticipating financial partnership from Metro government. The new 1700 ft. section will terminate at LaGrange Rd, providing a complete connection to Westport Rd.

Within the next few years, construction for a sidewalk from Lyndon Lane to Hurstbourne Ln. along LaGrange Rd. will begin which will tie into this Ormsby connection. Other phases of this project will begin as early as this year with an anticipated completion by 2024. Construction will begin east, nearest Hurstbourne Ln., and move west towards Lyndon Ln. in three phases. More to come on this subject as the timelines are known.
