Some notable events, excerpts, highlights, and issues for April include:

On April 1st, Lyndon Officers responded to the 100 Block of Kennedy Avenue as part of an investigation into reports of a male committing a sexual act in front of a juvenile at the Northeast Regional Library. Officers were unable to make contact with the suspect.

On April 5th, Lyndon Police responded to the 9300 block of New LaGrange Rd on a roll-over accident. The driver fled the scene. The driver was located in a residence in Shelby County by Shelby County deputies. He requested EMS and was transported via EMS to a Frankfort hospital.

On April 12th, Lyndon Officers responded to the 1800 block of Millgate on a reported home invasion. The caller heard an unknown vehicle in her driveway. The subject(s) started banging on the door and trying to forcefully open it. Officers were unable to locate the subjects.

On April 15th, Lyndon Officers responded to the 1100 block of Falconwood Rd on a glass patio door that was shattered by juveniles with BB guns.

On April 22nd, Lyndon Police responded to Fossil Court on a report of three small unattended children. One of the children was not wearing clothes. The children were taken to Norton Children's Hospital. Child Protective Services was notified.

On April 22nd, Lyndon Officers responded to the 1800 block of Telluride Way on a break-in in progress. The victim's child's father had climbed a balcony to the 2nd floor and entered through a window. When the victim attempted to contact police, the suspect snatched her phone. The victim grabbed her child and ran to the apartment office for safety. The suspect was located inside of the apartment. The suspect was charged with Burglary 2nd Degree, Intimidating a Participant in the Legal Process, Resisting Arrest, and Criminal Trespassing 3rd Degree.

On April 24th, Lyndon Police responded to the 8400 block of LaGrange Road on a death investigation. The caller had located a 93-year-old resident that was not alert or breathing. EMS confirmed the subject was deceased. The Jefferson County Coroner's Office is handling the investigation.

On April 26th, Lyndon Officers responded to the 900 block of Brixton Road on a report of a person publicly committing a sexual act in front of an apartment. Officers arrived and were unable to locate the subject.
