Some notable events, excerpts, highlights, and issues for May include:

On May 3rd, Lyndon Officers responded to the intersection of Whipps Mill Road and Lyndon Lane on a downed tree obscuring the view of the stop sign. Officers placed barricades in the area.

On May 4th, Lyndon Police responded to Winners Circle to assist EMS on a person down in a vehicle. EMS woke the subject who was cited for an improper plate and no operators license.

On May 4th, Lyndon Officers responded to the area of the 10100 block of Fossil Court on a person who fell into a drainage ditch. The subject was OK and did not want EMS. The subject lived nearby.

On May 5th, Lyndon Police responded to a business in the 8100 block of New LaGrange Rd regarding four males threatening an employee. Officers were unable to contact the suspects.

On May 5th, Lyndon Officers responded to the 600 block of Lyndon Lane on a potentially suicidal subject. The subject is known to officers and was taken to The Brook KMI.

On May 6th, Lyndon Police responded to the 2100 block of Dogoon on a potentially suicidal subject. Officers were unable to make contact with the subject. The family was going to take out a 202A petition.

On May 7th, Lyndon Officers responded to the 2100 block of Dogoon on the suicidal subject from the previous day. Jefferson County Sheriff's Office deputies served the 202A order.

On May 8th, Lyndon Police observed a vehicle fleeing a hit and run collision on New LaGrange Road run the stop light at New LaGrange Road and Lyndon Lane. The vehicle continued North on New LaGrange and lost control while attempting to turn into the Devonshire Apartments, striking a building prior to the officer's arrival. The subjects fled the scene. One subject was later captured by Lyndon Officers and additionally charged the subject for related drugs and a firearm.

On May 8th, Lyndon Officers responded to the 1700 block of West Creek Way on people fighting. The fight was over when officers arrived, and the parties would not cooperate with police. It is worth noting that this type of call is becoming more frequent at this location.

On May 9th, Lyndon Police responded to the 8400 block of Easton Commons Drive to assist EMS on a person down and non-responsive. The subject was transported to the hospital for treatment.

On May 9th, Lyndon Officers responded to the 10300 block of Ormsby Park Place to assist EMS on a 911 hangup. A subject possibly had a stroke and was transported by EMS to Baptist East for treatment.

On May 10th, Lyndon Police responded to the 8200 block of Vermissa Court on a suicidal and intoxicated subject. The subject was transported via EMS for treatment.

On May 11th, Lyndon Officers responded to the 8900 block of Riley on an intoxicated subject who drove her vehicle into the stairs at the above location. The subject was arrested.

On May 11th, Lyndon Police responded to the 9900 block of Corporate Campus regarding an Autistic adult who was on an upper floor and afraid of heights. The subject was refusing to leave. Fire responded and assisted officers in moving the subject downstairs.

On May 12th, Lyndon Officers responded to the 500 block of Vineleaf on a welfare check due to mail piling up and a food delivery sitting on porch for a few days. The subject was intoxicated and yellowing. The person was transported via EMS to the hospital for treatment.

On May 12th, Lyndon Police were flagged down at LaGrange Road and Ashmoor Lane regarding a person having a medical emergency. EMS responded and transported the unresponsive subject to the hospital for treatment.

On May 13th, Lyndon Officers responded to the 5000 block of Sunset Court on a check the welfare due to mail and packages piling up. A subject was located deceased inside of the residence and a death investigation was conducted. The Jefferson County Coroner's Office took over the investigation.

On May 17th, Lyndon Police responded to the 8000 block of Vine Crest on a person down in a vehicle. EMS woke the subject who refused treatment.

On May 18th, Lyndon Officers responded to the 9900 block of Corporate Campus on two groups fighting. Management requested the parties leave. One subject was intoxicated and belligerent. She refused to follow orders and get a ride home from her cousin, due to her intoxication. When the decision was made to arrest the subject, she pulled away and began to struggle, refusing to place her arms behind her back and assaulting an officer by kicking the officer in her stomach and body. The subject caused an estimated \$500 dollars in damage. The subject was charged with Resisting Arrest, Criminal Mischief 1st, Assault 3rd Police Officer, Disorderly Conduct 2nd, and Alcohol Intoxication in a Public Place.

On May 19th, Lyndon Police responded to the 8000 block of New LaGrange Road on a possible Autistic child at two businesses lost and alone. The subject left prior to officers' arrival. The subject was later located at New LaGrange Road and Benjamine Lane. The subject was schizophrenic and had walked to the location from Elizabethtown. The subject was voluntarily transported to the hospital for treatment.

On May 19th, Lyndon Officers responded to the area of Lyndon Lane and Warwick on a person down. The subject was extremely intoxicated. The subject was transported via EMS to the hospital for treatment.

On May 19th, Lyndon Police responded to the 1500 block of Stonewall at the request of the VA to conduct a welfare check on a suicidal subject. The subject advised officers that she was not suicidal and was just frustrated with the VA.

On May 20th, Lyndon Officers responded to the 600 block of Lyndon Lane on a female slumped over inside of a vehicle. The subject had three outstanding warrants and was also charged with the possession of Fentanyl.

On May 23rd, Lyndon Police responded to the 1700 block of Bridgeview Lane on a death investigation. The subject was found deceased by his wife. The death appears non-criminal and is being handled by the Jefferson County Coroner's Office.

On May 25th, Lyndon Officers responded to the 8100 block of LaGrange Road on an injury accident. An intoxicated male caused a head-on collision and fled the scene to a local bar. The subject admitted to having nine beers. The subject was transported to Baptist East Hospital for treatment. The subject was charged with DUI (aggravating circumstances), Leaving the Scene of an Accident, No Operators' License, and Failure to Product Insurance Card.

On May 26th, Lyndon Officers responded to the 8000 block of Post Oak Place on a subject threatening her neighbor. Officers separated the parties and took a report. Almost immediately after the officer cleared, the caller stated the female was doing it again. Officers arrived and witnessed the threats. The subject was arrested for Terroristic Threatening 3rd, Disorderly Conduct 2nd, and Alcohol Intoxication in a Public Place.

On May 27th, Lyndon Police were notified by Middletown Police regarding a subject wanted out of Shelby County staying in the 100 block of North Hurstbourne Parkway. Lyndon Officers confirmed the subject was staying there and attempted to make contact. The subject answered the door, refused to open the door, and feigned being an older female. Given the subject's history with weapons, the decision was made to contact St. Matthews Police SWAT. Lyndon and Middletown Officers held the scene and ensured public safety until St. Matthews SWAT arrived. St. Matthews negotiators contacted the subject and he eventually surrendered and was taken into custody without incident. While conducting a safety sweep of the location, St. Matthews SWAT located a suspected bomb and related materials. The SWAT Officers exited the location and LMPD's Bomb Squad was contacted. The subject also has a history with explosives. LMPD responded along with the FBI. The location was examined, and it was determined that the items were not a danger to the public. The location was cleared and returned to the business' control. The subject was arrested on his outstanding warrant.

On May 30th, Lyndon Officers responded to LaGrange Road and Whipps Mill Road on a vehicle versus a CSX electrical box collision. The vehicle was in a ditch and unoccupied when officers arrived. The vehicle was towed.
